HIGHLIGHTS:

Rural Communities Opioid Response Program (RCORP); deadline 4/24/20

RCORP is a multi-year initiative by the Health Resources and Services Administration (HRSA) aimed at reducing the morbidity and mortality of substance use disorder (SUD), including opioid use disorder (OUD), in high risk rural communities. For FY20, the program is funded at \$89 million.

Community Facilities TAT Grant – Disaster Relief Act 2019; deadline 4/30/20

As part of the Additional Supplemental Appropriations for Disaster Relief Act of 2019, the Rural Housing Service’s Community Facilities (CF) Technical Assistance and Training (TAT) Grant Program has announced \$7.5 million in supplemental grant funding for eligible expenses related to the consequences of Hurricanes Michael and Florence and other disasters occurring in the calendar year 2019.
