We will work directly with all County Emergency Management Managers across the Centralina nine-county region. This is a collaborative effort, and we will be building upon, not replacing, the County and City-level emergency plans through a series of plan evaluations, assessments, focus groups and one-on-one meetings. We intend to create a **Centralina Disaster Resilience & Emergency Management Regional plan** and framework for ongoing collaboration through a **Regional Resilience Roundtable**.

- Identifying opportunities for inter-local efficiency and capacity.
- Developing a structure for ongoing regional collaboration.
- Positioning the region and our counties to better respond to and recover from disruption and disasters.
