#### **Preserve Treasury's ARPA Support**

With the Congressional appropriations process under way, the National Association of Counties, National League of Cities and others are directing local governments and key stakeholders to ask their Members of Congress to support adding an American Rescue Plan Act (ARPA) flexibility bill to the year-end omnibus appropriations package or to the

next must-pass legislation. The bipartisan bill is titled the State, Local, Tribal, and Territorial Fiscal Recovery, Infrastructure, and Disaster Relief Flexibility Act (S. 3011/H.R. 5735). The bill would ensure the Department of Treasury continues to provide administration support to communities for ARPA programs, including the Coronavirus State and Local Fiscal Recovery Fund (SLFRF) program. It would also give communities more flexibility to use remaining recovery funds on transportation, infrastructure, economic development and disaster relief projects. The call to action came after the Department of Treasury recently told ARPA recipients that it plans to reduce staff and diminish services for ARPA programs due to funding shortfalls.

2021-2022 Annual Report Highlights



Our annual report highlights our work at the regional, community and individual levels for the year ending June 30, 2022. We focused this year on visionary planning initiatives as well as strategic implementation to transform ideas into action. We worked with several communities on strategic planning processes, launched the region's five-year **Comprehensive Economic Development Strategy** and began the critical task of implementing key recommendations from the **CONNECT Beyond** regional mobility initiative. Collectively this work demonstrates our commitment to the big ideas that move our region forward and fulfilling our role in ensuring

that positive change occurs at the local level. In FY22 we also:

- Launched a **Regional Dialogue Series** to hear from stakeholders and inform our three-year strategic planning process.
- Proactively engaged our members about the **American Rescue Plan Act** and provided a range of supports to aid local governments in implementing their ARPA funds.
- Completed the pilot year of the Regional Resilience Collaborative to build capacity in our regional emergency management so that we can better recover from future disasters.
- Created and managed a regionwide **COVID-19 vaccine outreach** campaign to engage older and disabled adults.
- Got creative in our approaches to connecting our workforce and businesses to fill our talent pipeline and address the changing nature of work due to the changing nature of work due to the pandemic

## **Pedestrian Safety Month**



Each October, Pedestrian Safety Month is observed to increase awareness around pedestrian safety and remind drivers to watch for pedestrians every time they are behind the wheel. Pedestrian Safety Month recognizes that "at some point in the day, everyone is a pedestrian." For older adults and people with disabilities, navigating our built environment as a pedestrian can be a particularly challenging and dangerous process. Through regional initiatives such as **CONNECT Our** 

**Future** and **CONNECT Beyond**, Centralina has been a leader in providing equitable mobility. As an extension of this work, Centralina received grant funding from the Charlotte Area Transit System to support regional efforts to enhance and improve transportation options for older adults and people with disabilities in the Charlotte Urbanized Area. As part of this funding, we partnered with Iredell County Area Transit System (ICATS) and the City of Statesville to conduct walk audits around bus stops in Statesville. The resulting reports, which will be released in October 2022, will include recommendations on how ICATS and the City of Statesville can make transit stops more safe, comfortable and accommodating for pedestrians.

She directs greater Centralina's work related to land use and transportation, healthy community initiatives, energy and the environment. In 2022, she received the Planning Distinguished Alumni Award from East Carolina University and is a member of the East Carolina faculty in the Community and Regional Planning Program. CDBG Administration: Centralina supported Mecklenburg and Union County in another successful Community Development Block Grant (CDBG) Entitlement program year. Centralina serves as the administrator and

assists with the efficient and effective delivery of funds to non-profits, housing and homelessness providers, county departments, local municipalities and other public service agencies.

**CEDS Update:** The Centralina Economic Development District (EDD) launched the Comprehensive Economic Development Strategy (CEDS) update to the 2017-2022 Prosperity for Greater Charlotte CEDS. Centralina CED serves as staff to the Centralina EDD and has been working with the CEDS Steering Committee for the adoption of the CEDS update in November 2022.

#### **PEARLS to Address Depression in Older Adults**

Did you know that one in five older adults may experience depression? Studies show that the burden of depression tends to be higher among those who are isolated, live alone, live in poverty, speak a different language and have complex health issues in addition to people of color. Centralina Area Agency on Aging is responding to this prevalent issue through a partnership with the University of North Carolina Asheville on an initiative called PEARLS (Program to Encourage Active Rewarding Lives). This community- and evidence-based pilot program is designed to reduce depression in physically impaired and socially isolated people. Centralina will connect and serve 205 individuals over the course of three years to help older adults develop the skills they need to maintain their health, happiness and independence.

## CLT Aviation Academy: Now Accepting Applications

#### **Chapter 160D Extension: Communities Under 1,500**

In 2019, the North Carolina General Assembly (NCGA) updated state planning regulations for local jurisdictions, commonly referred to as "Chapter 160D requirements." These revisions required all communities wishing to enforce zoning regulations to have an adopted, current land use plan by July 1, 2022. Acknowledging the challenges this requirement poses for smaller communities, the NCGA recently extended the deadline to July 1, 2023, for municipalities with populations at or under 1,500. Since the original revisions were passed, Centralina has been working with counties and municipalities to align land use plans with Chapter 160D requirements and reflect shared community visions for the future. Our staff will inventory our communities' populations and engage with qualifying municipalities soon to ensure your land use planning needs are met.
