#### The Inflation Reduction Act

Earlier this summer, the Inflation Reduction Act (IRA) was passed by Congress and signed into law by President Biden. The legislation provides federal action in three main areas: taxes, healthcare and climate. To deliver approximately \$370 billion in climate and clean energy funding, the Act makes reforms to the tax and healthcare systems,

including a new minimum corporate tax, an extension of ACA health insurance subsidies and authorizing Medicare to negotiate lower prescription drug prices. Local governments will have the opportunity to pursue clean energy

initiatives, to strengthen their communities' resiliency and to reduce emissions through competitive grants programs, local investments and clean energy tax credits provided for in the IRA's climate provisions. To accomplish this, the Act reinvigorates some existing programs while creating several new ones.

# Centralina Learns: Managing ARPA Allocations Under \$10 Million

Centralina Regional Council held a Centralina Learns session on Wednesday, August 17 about American Rescue Plan Act (ARPA) spending for allocations under \$10 million. We had a great turnout and participation as our session provided an overview of the updated guidance the U.S. Treasury released on July 27 as well as considerations for spending approaches and following good governance. If you missed the session, here are six points that you need to know.

1. The updated guidance released from the U.S. Treasury on July 27 is only relevant if your community elected "Revenue Loss" as your

- ARPA spending category. This includes if you are spending the funds on salaries and benefits and/or other general government services. This guidance is also relevant if your community is planning on spending the funds on equipment/infrastructure under the revenue loss category.
- 2. Under this new guidance recipients may update their Revenue Loss election, in future reporting cycles through the April 2023 reporting period (US Treasury Final Rule FAQ 3.1)

### Land Use Planning in Dallas, Stanley and Wingate

In 2019, the North Carolina General Assembly completed a comprehensive update and modernization of the state's planning regulations for the first



time since 1905. As part of this update, any community wishing to enforce local zoning was required to adopt a current land use plan by July 1, 2022. A land use plan captures a community's vision, values and goals for the future by translating community feedback into actionable policy

recommendations and includes a future land use map to guide development. Land use planning provides an opportunity to integrate land use practices with other local priorities, such as transportation connectivity, healthy living, infrastructure investment and economic development. However, developing a land use plan is a significant undertaking that requires extensive research, data analysis, community engagement and plan design to provide the community with an effective tool to guide future decisions. Many communities throughout North Carolina had to rapidly identify a path toward developing a plan or risk challenges to their zoning ordinances if they did not have plans in place before the deadline.

### **Pilot Program: Safe At Home**

Fall risks impact everyone from infancy into older age. From the moment babies take their first steps to running errands as an older adult, fall risks exist. However, older and disabled adults are affected more by the potential effects of falls. A fall can be a gateway to other problems, leading to a decline in health. BlueCross BlueShield of North Carolina (Blue Cross NC) recognized this risk and is piloting a program called Safe At Home, which focuses on fall prevention education and home modifications for adults aged 55-65 with a history of falls or fractures, visual impairment or use of medications which may cause impairment. Centralina Area Agency on Aging (AAA) Director, Linda Miller, shares, "Blue Cross NC's Safe At Home pilot program and Centralina AAA are a natural fit as they both share fall prevention and wellness goals. Centralina is excited to be a part of this program."

# The Power of Partnerships: Helping Older and Disabled Adults Beat the Heat of Summer



As individuals age and develop chronic medical conditions, they are less likely to sense and respond to changes in temperature and they may also be taking medications that can worsen the impact of extreme heat. Operation Fan Heat Relief helps vulnerable adults at risk for heat-related illnesses stay safe during the summer. Individuals who are 60 and older, as well as adults with disabilities, are eligible to sign up for assistance. To support this important program,

Centralina Area Agency on Aging partners with the State Division of Aging and Adult Services and utilizes its network of local service providers throughout our nine-county region to administer supplies.

The NC Department of Commerce's Rural Economic Development Division is accepting applications for the **Rural Transformation Grant**. The state has appropriated \$50 million of its ARPA allocation for this funding opportunity. Open to local governments in Tier 1 & 2 Counties and Rural Census Tracts in Tier 3 Counties. The program will provide grant resources, training, technical assistance and education programs to help acquire resources, advance project implementation, build capacity and respond to issues related to the COVID-19 pandemic and recovery. The grant will support projects in four categories:

- Downtown Revitalization
- Resilient Neighborhoods
- Community Enhancement for Economic Growth
- Rural Community Capacity Building
