- "The Continuum of Care is a community plan to organize and deliver housing and services to meet the specific needs of people who are homeless as they move to stable housing and maximum self-sufficiency. It includes action steps to end homelessness and prevent a return to homelessness."

# It Takes a Village ...

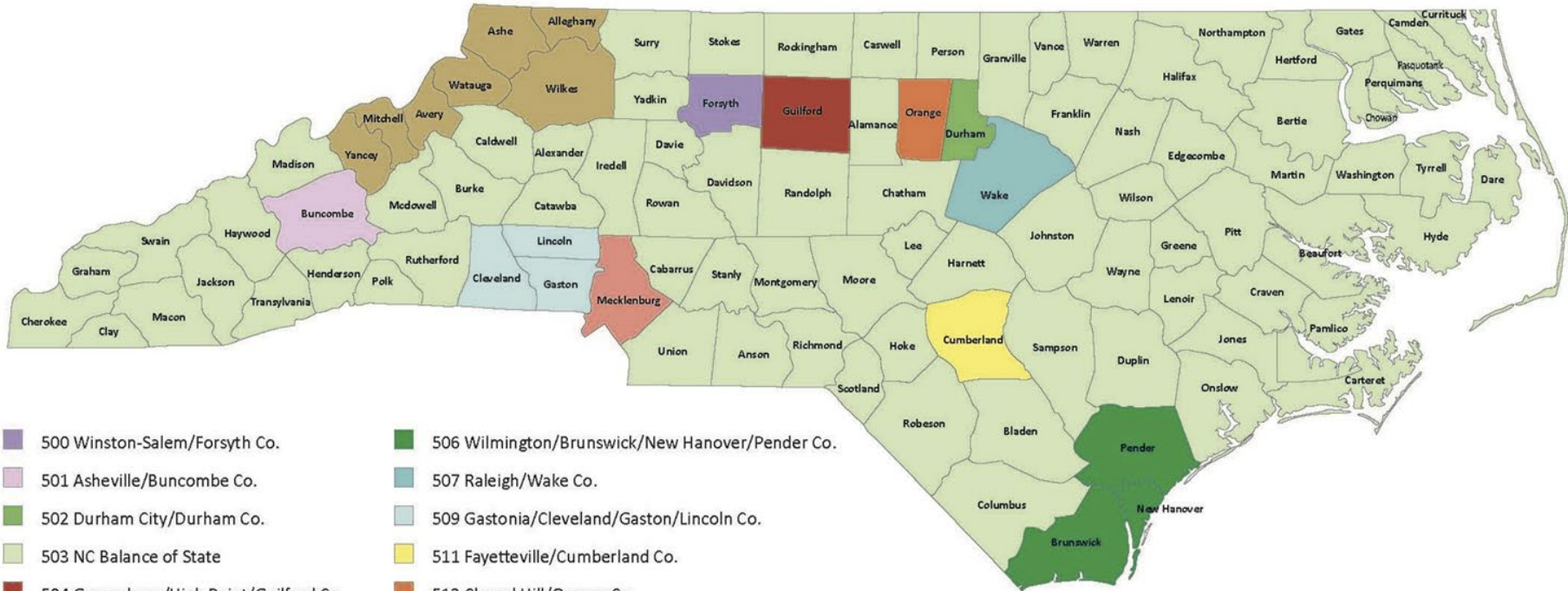
The Continuum of Care is a group:

- Must be composed of representatives of relevant organizations within the geographic area served by the Continuum.
- Once established, the CoC is required to appoint a CoC board and to designate a Homeless Management Information System (HMIS) lead agency and a collaborative applicant to assist with its responsibilities

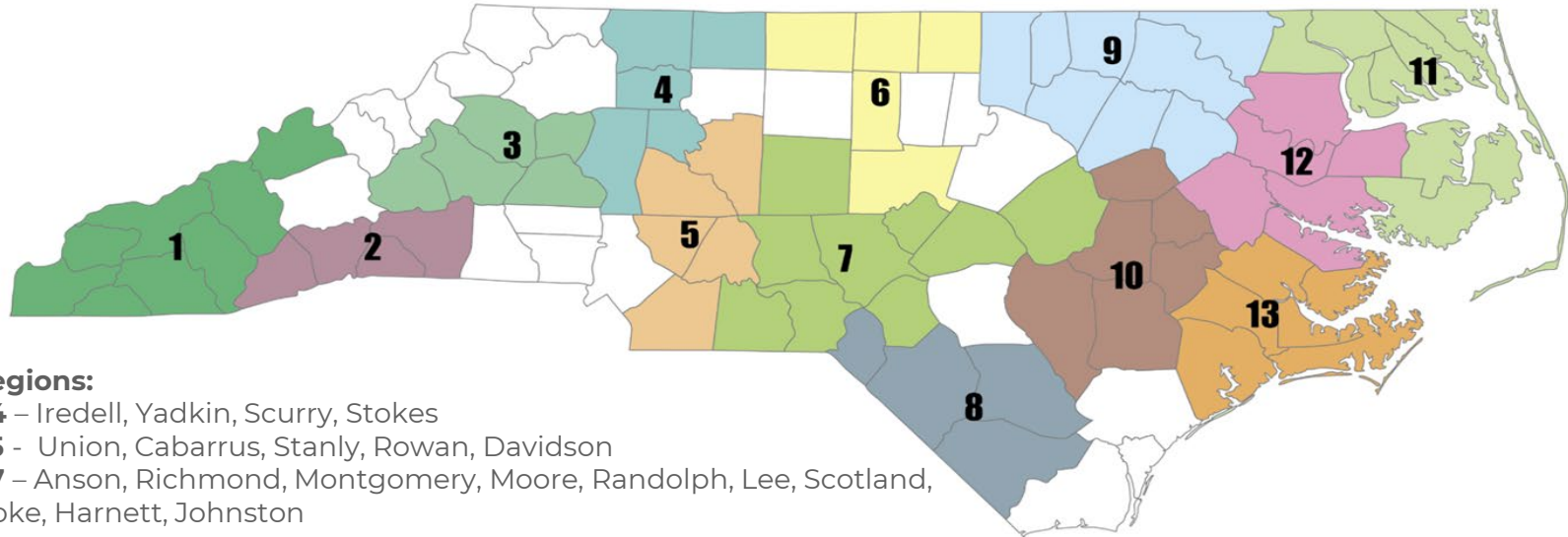
