





How would you score the level of engagement and collaboration with your jurisdiction in the development of the Regional Hazard Mitigation Plan?



Inspections and Permitting Subcommittee

Objective

- Oversee safe repair, restoration, and rebuilding of damaged structures
- Overview
 - Comprised of certified building inspectors and engineers to carry out inspections and staff knowledgeable in permitting policies and procedures
 - Staff should have access to policy makers to enact temporary amendments to permitting procedures or development restrictions such as temporary moratoria, when necessary

Inspections and Permitting Subcommittee Phased Activities

Pre-Disaster Preparedness

- Develop policies for expedited permit processing and waiving/reducing post-disaster permit and development fees
- Identify building inspector and engineer resources
- Improve data collection and management systems

Transition Phase

- Request inspectors and engineers through mutual aid
- Establish a method to indicate building safety status with building owners and the public

Short-term Recovery

- Expedite permitting processes
- Develop criteria to allow for temporary shelter/housing permits

Long-term Recovery

- Publicize information on amended construction permit application processes
- Monitor potential contractor scams
- Coordinate with the Damage Assessment Subcommittee regarding damaged properties

Community Engagement and Long-term Planning Subcommittee

Objective

 Work with the community to identify recovery objectives and priorities and execute the vision for a new and improved community

Overview

- Facilitate public meetings, forums, and other community events to gather community input and feedback on recovery progress.
- Members will need a strong understanding of the makeup of the community, including the complex social, economic, and demographic factors related to recovery.

Community Engagement and Long-term Planning Subcommittee Phased Activities

Pre-Disaster Preparedness

- Identify roadblocks related to land-use regulations
- Develop and adopt a pre-disaster recovery ordinance
- Connect with local non-profits
- Prepare neighborhoodspecific overviews
- Discourage unsolicited donations
- Promote community preparedness

Transition Phase

Monitor recovery activities

Short-term Recovery

 Initiate community engagement by soliciting input and feedback on recovery and rebuilding objectives

Long-term Recovery

- Engage the public in rebuilding and recovery priorities
- Identify rebuilding restrictions
- Engage recovery committees and local recovery partners
- Draft a recovery strategy
- Track implementation of the recovery strategy



Information Collection

- 1. Gather any studies or reports that have been done on the project you want to initiate.
- 2. Look to see if there are any disadvantaged, or underserved populations.
- 3. How will the project reduce the risk to climate change.
- 4. Have you included any nature-based solutions.
- 5. Look up the population that will be affected by the Mitigation project in total.
- 6. Know the who, when, why, what, and how of the project.
- 7. Check the jurisdictions building codes for information on nature based solutions, hazard mitigation, etc.
- 8. Ensure your jurisdictional leaders are on board to do the project.




Projects and Prioritization – Mitigation Plan




Always start with your Mitigation Plan for projects you want to implement. If you are applying for FEMA funding the project must be identified in the actions.







Create Recovery Plans	Develop a Long-Term Recovery Plan that established goals and metrics for successful recovery by the completion of the RRC Recovery Planning Workshop.	Attend RRC Recovery Workshops, Participate in the Recovery Technical Assistance, Promote Recovery with peers and potential stakeholders.
Integrate Mitigation Actions with Recovery Programs	While developing the Pre-Disaster Recovery Plan with the RRC Workshop (2023-2024), review the Hazard Mitigation Plan (HMP) actions and align as many of the activities as possible to identify efficiencies in funding, staffing, and resources.	Review the HMP mitigation actions in a joint session with the Long-Term Recovery Committee (LTRC) and Local Emergency Planning Committee (LEPC). Identify common efforts and align priorities. Update the HMP and the LTRP accordingly.
Manage Financial Recovery	Develop a Financial Recovery Plan that that involves the finance department and support the whole community resilience by the completion of the RRC Financial Recovery Program.	Participate in the RRCs Financial Recovery Program.
Pursue Grant Opportunities	Identify, assess, and apply for state and federal grant opportunities that are offered to municipalities in support of mitigation and recovery goals, during the 2023-24 grant cycle.
